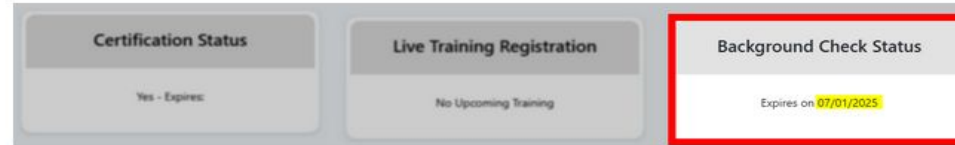

- 2) Locate the “Background Check Status” section of your account as highlighted in the sample below.



- a. If your expiration date is **AFTER 7/1/2025**, your screening is still current. You can Log Out. You do not need to take any additional steps at this time.
 - b. **If your expiration date is 7/1/2025 or before**, please continue to Step 3 to renew your background check requirement.
- 3) Locate the **Criminal Background Check Renewal** module in your Required Trainings area and click **Start** to complete the process for renewing your background check.

If you do not complete a background check, but are within the expiration window for this Fiscal year, the system cannot approved you until it is complete.

*Once you have completed your Criminal Background Check, please allow for 1 to 10 **business days** for it to process.*

If your expiration window is **after 7/1/2025** (7/2/2025 and on), once you complete your training, you are done with your Safe Environment Requirements for the 2024/2025 Fiscal year.
