## TERMS AND CONDITIONS

John Paul Pilgrimages & Tours (JPP&T) agrees to operate tours under the following terms and conditions. A customer's payment for reservation on any tour shall constitute consent to all provisions in the Terms and Conditions published herein. These may also be viewed at [www.johnpaulpilgrimagesandtours.com](http://www.johnpaulpilgrimagesandtours.com) or by requested by mail to John Paul Pilgrimages and Tours, C/O Legal Division, 104 N. ### RESERVATION AND PAYMENT

An initial non-refundable deposit per person as stated in the brochure is required to hold your reservation. The initial deposit must be turned in with a complete registration form. Balance is due on the date stated on the brochure, or no later than 90 days prior to departure. For reservations made less than 90 days prior to departure, full payment is due immediately. A \$50 per person late fee will be applied to any final payment not received by the due date. JPP&T accepts personal checks, cashier/bank checks, money orders, and credit cards (American Express, Discover, Visa and Master Card). 'Check/Money Order Discount' is only applicable if all payments per registration are made by check or money order. Should there be insufficient funds a \$25 service fee will be charged. Every reservation must be accompanied by a signed registration form, which indicates acceptance of JPPT Terms and Conditions.

### COST

Prices are based on a minimum group size of 30 participants. If this group size is not met 90 days prior to departure JPP&T may cancel the trip, or provide registered participants the option to continue at a different price, calculated based on the final group size.

### NOT INCLUDED

Passport fees, visas (where required), optional tours and gratuities for these tours, and any other items of a personal nature including (but not limited to) excess baggage, laundry, alcoholic beverages, and mini-bar charges incurred in your hotel room are not included. Lunches or other meals not specified in the itinerary are not included. Drinks with meals are not standard. This includes soft drinks, coffee, tea, and alcohol. Some meals may have drinks included on your tour, refer to your specific itinerary, Tour Organizer and Guide for details.

### BAGGAGE

No responsibility is incurred by JPP&T for loss or damage to baggage or any of the customer's belongings. JPP&T is not responsible for airline charges incurred for passenger bags. The passenger is responsible for confirming baggage size, weight and other rules from the airlines directly after receiving final documents including airline tickets.

### REQUIRED TRAVEL DOCUMENTS

It is the customer's responsibility to acquire all required travel documents including (but not limited to) passports, visas, and immunizations in a timely manner. If you do not have these documents by the deadline, JPP&T is not responsible for providing a refund for cancellation of your tour reservation.

### PASSPORT REQUIREMENTS

A valid US Passport is required of all passengers. You must apply for a passport immediately if you do not have a valid one now. All passports must be valid for at least six months after the tour. Passports with the stamps of Syria, Iran, Korea and some others may not be permitted. Visit <http://travel.state.gov/> for more information. US passengers do not need a VISA to European Union member countries.

### LAST MINUTE BOOKINGS:

JPPT does not charge for last minute bookings; however the nominal fee of \$50.00 will be assessed to cover costs related to expeditious document delivery. If the cost of airline ticket is higher, passenger pays difference.

### CANCELLATION BY JPP&T

JPP&T reserves the right to cancel any tour in full or part prior to departure for any reason, including insufficient number of participants, in which case a full refund will be given. This refund does not include insurance, or any services booked on your own or separate from the JPP&T tour package. JPP&T accepts no responsibility for that which is described under SCHEDULES AND DELAYS and RESPONSIBILITY CANCELLATIONS AND REFUNDS

Refunds are limited. Cancellations MUST be confirmed in writing to be considered for a refund. JPP&T will make every effort to offer a full refund, however if expenses are already incurred, these expenses and any penalties issued by the airline/hotel/restaurants etc. will not be returned. Initial deposit and travel insurance are non-refundable. You are responsible for the cost of any non-refundable airline tickets that have been issued on your behalf plus the following cancellation fees per person: 90-61 days prior to departure: 20% of trip price, 60-31 days prior to departure: 40% of trip price, 30 to 15 days prior to departure: 60% of trip price, 14 to 0 days prior to departure or no show: 100% of trip price. We strongly encourage purchasing Travel Cancellation Insurance.

### PARTIAL OR COMPLETE WITHDRAWAL AFTER TOUR BEGINS

Once the tour is in progress, no refund will be made for ANY unused portion of the tour. JPP&T also reserves the right to withdraw your membership of the current tour at any time if your actions impose upon or disturb the other members of the tour to a great degree. All additional costs to send a tour member home will be paid by that member.

### CLAIMS

Claims for refunds must be submitted in writing to JPP&T within 14 days of cancellation or prior to the trip departure- whichever comes first. Unused travel documents must be submitted and returned with the claim. Please allow a minimum of six weeks to process a refund. Refund requests for lost airline tickets, travel vouchers, or associated penalties, or for absenteeism, missed sightseeing, meals, or other unused services are not granted by JPP&T. Please refer to Cancellation and Refunds and/or Travel Insurance.

### TRAVEL INSURANCE

Travel insurance, Medical Insurance, Trip Cancellation and other related insurance is optional but highly recommended by JPP&T. Your Tour Organizer can provide travel insurance information to participants at the time of registration. Please review the travel insurance information provided. We offer Travel Insurance options through Travel Insured INC, and can recommend their service. You may choose any Travel Insurance Company you would like. At the time of Registration you must elect to purchase or decline Travel Insurance on your registration form.

### SCHEDULES AND DELAYS and RESPONSIBILITY

All travel times are based on the last timetable and best information available. JPP&T accepts no responsibility for cancellation, losses or accidental expenses due to delays or changes in schedule by the airlines, hotel overbooking, or default, sickness, weather, strikes, war, quarantine, riots or insurrections, political disorders of any type, acts of God, criminal activity, epidemic, act of terrorism, State Department Advisory or Warning, quarantine, attack by animals, or other such similar causes. All such losses or expenses will be borne by the passenger/customer.

### AIR TRANSPORTATION

Trip fees are based on economy class seating. Should a customer prefer upgraded airline seating, it is the customer's responsibility to make a request in writing prior to the purchase of airline tickets. Furthermore, all additional charges associated with this upgrade will be added to the customer's total trip cost. In general, seating assignments are at random and cannot be adjusted until you are on the plane should you choose to trade with someone. JPP&T makes an effort to seat tour participants together, but is restricted to availability of the airline.

### POSSIBLE CHANGES TO ITINERARY OR HOTELS

Occasionally, the land portion of your tour may be altered due to transportation schedules, airline or other delays, weather, strikes, road construction, or for war, quarantines, riots or insurrections, political disorders of any type or other unforeseen reasons. JPP&T reserves the right to substitute hotels or any other tour elements mentioned in the tour brochure, including the right to alter the itinerary to substitute any city or country, when more than one country is included on the itinerary, for a package of equal

duration and value when the trip is within 91 days of departure.

### ABOUT YOUR HOTEL

We use Government rated Hotels that are chosen based on location, cleanliness, services, and those which are typical of the local area. All rooms have private bath and toilet facilities. In all cases, hotel management assigns your room. Location, view, and size may vary. Rooms are assigned based on the provided rooming list and the hotels' abilities to fulfill rooming requests. Air conditioning is not standard at all hotels and cannot be guaranteed. Note: some groups are arranged with lower or higher class overnight accommodations. Student and other groups may be arranged with hostels which may have three or more people to a room, and a shared bathroom down the hall, or other less expensive group housing. Check with your program material and group organizer for more information.

### SINGLE ROOMS

Hotel rates and reservations are based on double occupancy. Single rooms may be requested for an additional fee and based upon the availability of each hotel. JPP&T cannot guarantee a single room will be available. Should you pay the single room fee stated in the trip brochure and are not provided with a single room, a refund will be given for the difference in cost. It is your responsibility to specify a roommate. If you do not specify a roommate and one cannot be arranged, you will be charged the stated fee for single room occupancy during your trip.

### TARIFF AND EXCHANGE FLUCTUATIONS

All prices herein are quoted in US dollars and are based on tariffs and exchange levels in effect January 2015.

### MEALS

Provided meals are specified in the travel itinerary. All other beverages and meals are your responsibility. JPP&T reserves the right to make substitutions or trade meal days/times so long as they remain of equal or greater value.

### HEALTH REQUIREMENTS

Trips offered by JPP&T require significant walking as many attractions and destinations are not accessible by motor coach. These trips are often not wheelchair accessible. There will be times requiring a lot of walking, often up and down hills, rough terrain, cobblestone, stairs, uneven and slippery surfaces, possibly at high elevation. We suggest you exercise and prepare yourself to walk several miles without discomfort.

### MEDICAL CONDITIONS

While we strive to provide the highest level of service to our passengers with special medical and dietary needs, we cannot guarantee any special facilities, assistance or specific meals for individuals with such needs. Please advise us of any specific needs and we will do everything in our ability to accommodate you. Ultimately, it is each participant's responsibility to arrange for such assistance as required. JPP&T will not be responsible for any condition arising before, during or after your tour.

### ACCESSIBILITY AND SPECIAL ASSISTANCE

All accessibility needs due to disability must be provided in writing at the time of deposit. This allows JPP&T the opportunity to attempt to ensure your airline seat, hotel, and motor coaches are available to fit your needs to the best of our ability. Please remember that the American's with Disabilities Act (ADA) is not applicable in other countries and JPP&T cannot guarantee nor is it responsible for any denial of service by carriers, hotels, restaurants, or other independent suppliers. JPP&T requires that any participant needing special assistance arrange a physically able companion(s) to accompany said participant for the entirety of the trip.

### CASH FEE / GRATUITIES

Gratuities are not included in the tour cost. JPP&T offers highly competitive pricing for its customers. Depending on the particular tour, an amount of approximately \$8-\$12 per person per day will be collected Day 1 to cover certain entrance fees, parking fees, toll roads, local attraction guides, and other associated cash expenses. What is collected on Day 1 is not kept as a gratuity by your Escort, Organizer or Spiritual Director and we propose you reward them if you are satisfied with their service.

### TRAVELERS UNDER THE AGE OF 18

Those traveling under the age of 18 will be considered a minor and must be accompanied by an adult. The adult and minor will be paired as roommates for the trip.
